

BACKGROUND

The Mountain Counties Water Resource Association (MCWRA) works to promote the statewide importance of Sierra Nevada water resources through advocacy and collaboration. The association strives to be the premiere advocate influencing water policy and protection of the Sierra Nevada watershed. MCWRA serves as a valuable resource for the District via coalition-building opportunities while keeping apprised of pertinent developments and information related to the industry, allowing GDPUD to remain responsive to best protect the interests of the Georgetown Divide's residents and water utility.

DISCUSSION

The MCWRA Board consists of six (6) elected Water Board members and three (3) county supervisors. Directors represent the membership at large in a regional capacity, not a specific entity. MCRWA is seeking to elect four (4) Board of Directors from its executive membership; three (3) elected Water Board Directors and one (1) elected county supervisor. Solicitation for candidates will close on Wednesday, November 27th, 2024. Representation is of benefit to GDPUD, and the Board is encouraged to identify potential candidates for submission and consideration. Candidate recommendation approves associated travel costs including mileage for MCWRA board of director participation should the candidate be appointed.

FISCAL IMPACT

There is no fiscal impact associated with this action beyond the already provided membership fees.

CEQA ASSESSMENT

This is not a CEQA project.

RECOMMENDED ACTION

Staff recommends the Board of Directors of the Georgetown Divide Public Utility District (GDPUD) identify potential candidates for the MCWRA Board and authorize staff to submit the candidate form and interest statements to MCWRA for consideration.

ALTERNATIVES

The Board may choose to forego recommending candidates for the MCRWA Board and forfeit any benefits associated with the representation.

Nomination Process

The Governance Committee shall, through the Secretary, solicit for qualified, interested candidates from its Executive Membership (Chief Executives). Solicitation for additional candidates is now open and will remain open until close of business Wednesday, November 27, 2024.

If there is interest from your organization in nominating a representative to sit on the MCWRA Board of Directors, please complete the Candidate Interest Statement below and return directly to Emily Randall at emily@caporussocommunications.com.

Directors

The MCWRA Board shall consist of six (6) elected Water Board members (in that capacity) and three (3) County Supervisors (in that capacity). <u>Directors shall represent the membership-at-large in a regional capacity</u>, not a specific entity.

Qualifications of Directors

Representative of an Executive Member as an elected official with service at the member organization in an elected capacity for a minimum of one (1) year; and dedication to the purposes of Mountain Counties stated in Article III of the Bylaws.

After the close of the candidate solicitation process, the MCWRA Governance Committee will review the qualifications of the submitted candidates and nominate those qualified as per the Bylaws. The Governance Committee will establish a list of nominees that meet the qualifications and will prepare an election ballot for your organization. This ballot will be transmitted via email to you.

Election of Directors

All Executive Members may vote on the election of MCWRA Directors. A ballot with the name, title, and organization of each nominee will be issued and directed via email from the Secretary to the Chief Executive of each Executive Member organization.

The Chief Executive of each Executive Member can vote on behalf of that Executive Member for MCWRA Directors. Each Executive Member organization shall be entitled to cast one (1) ballot, and may not cast more than one vote for any one nominee for Director. Voting will remain open for 30-calendar days or until all ballots have been cast (whichever comes first).

If MCWRA has an uncontested election for new Board members, the Association will dispense with balloting and the candidates are thus considered elected by consent and acclamation.

The term of the Director will run from January 2025 through December 2028.
