Operations Update

The 2024 irrigation season ended October 15th which delivered a total of 492 miners inches to a total of 379 customers. Following the season the District focuses on critical infrastructure improvements and/or repairs during favorable weather conditions to ensure future water reliability. A number of sections of open ditch are scheduled to be improved with concrete lining or pipe replacement. These efforts have reduced the total water demand resulting in more water available for potential District customer growth. The raw conveyance tunnel first used in the 1960s, which transports all water to the District for customer use, will undergo an assessment to evaluate overall condition and identify any needed repairs.

Improvements to the raw water conveyance system provides the District the ability to produce high-quality safe drinking water. The production and distribution infrastructure varying in age from early 1970s to 2000s require improvements and repairs to maintain continuous service. Short-term water treatment improvements include automation and water quality instruments that provide reliable water treatment process monitoring. Distribution operators routinely repair or replace aging service lines and/or mainlines. To help identify significant distribution network upgrades, distribution operators have been installing master supply meters in targeted locations throughout the system. A State grant has been utilized to install backup power generators at pump station facilities and equip recently installed customer meters with the capabilities for hourly usage monitoring.

Reminder: Rainy Season Considerations

With rainy season upon us, the G.D.P.U.D. wastewater team would like to remind you to check the cleanouts, lids, and risers of your wastewater treatment system. It is important for all homes with onsite systems, as well as those on the Community Disposal System (CDS), to ensure their systems are watertight. This helps prevent inflow and infiltration (I&I), which can cause problems, possibly overloading the leach field and leading to wastewater backups in the septic tank. This can also reduce the system's ability to treat waste properly, and in some cases, may cause contamination of the groundwater as the soil becomes saturated.
