4. AUBURN LAKE TRAILS WATER TREATMENT PLANT – AWARD CONTRACT AND ISSUE NOTICE TO PROCEED

- A. Discussion On June 8, 2016, District staff opened bid proposals for the construction of the Auburn Lake Trails Water Treatment Plant Project. This event was open to the public, with several contractor representatives present. The District received 10 bid proposals. After a review of the bid proposals, <u>Myers and Sons Construction LP</u>, was identified as the contractor having submitted the apparent low bid.
- **B.** Possible Board Action Staff recommends that the Board award the Contract to Myers & Sons LP, the lowest responsible bidder, in the amount of \$10,249,000, for the construction of the Auburn Lake Trails Water Treatment Plant upgrades, conditional upon the execution of the State Revolving Fund Loan in the amount of \$10,000,000. This action would include authorizing staff to process all paperwork associated with the construction contract including but not limited to the issuance of a Notice to Proceed.

A. Discussion – This is an opportunity for the Board to discuss and approve a human resources consulting firm to assist the District with its search for the hiring of the new General Manager.

BACKGROUND / DISCUSSION

On June 8, 2016, District staff opened bid proposals for the construction of the Auburn Lake Trails Water Treatment Plant Project. This event was open to the public, with several contractor representatives present. The District received 10 bid proposals. After a review of the bid proposals, Myers and Sons Construction LP, was identified as the contractor having submitted the apparent low bid. A bid summary is provided below.

Subsequent to the bid opening (within 3 working days), the three apparent low bidders were required to submit additional documentation supporting their DBE and Good Faith Efforts. The DBE and Good Faith Efforts Documentation is a requirement of the State and Federal Funding. After a review of the DBE and Good Faith Efforts Documentation, Myers and Sons Construction LP, is identified as the Contractor having submitted the lowest responsible bid.

Information shared at the Board Meeting of August 9, 2016 identified an estimate of

remaining funding needs in the amount of \$12,000,000. Key elements of that estimate would include facility construction, contingencies, construction management and administration costs. Also shared at the meeting of August 9th was the funding summary (see below) which identified the source and amount to cover the anticipated remaining expenditures.

An element of the Installment Sale Agreement (Loan), with the State Water Board, requires their approval, in writing, to award the construction contract to <u>Myers and Sons Construction LP</u>, the selected lowest responsible bidder. <u>The Water Board has provided the District with that written approval to award the construction contract</u>.

District Counsel continues to assist staff in the finalization of the State Loan. Recent efforts, on the part of Counsel, have included a request that the State provide the District with an assurance that the loan will be approved. The response from the State is that they cannot provide an assurance that the loan will be approved. That response also included the following statements: "Staff are reviewing Georgetown's final budget, bids and other information, and are aiming to have everything complete for execution in early September. The eligible start date for this project is July 22, 2016, which means that if the loan is executed, we can reimburse for eligible costs incurred on or after that date."
