On October 28, 2022, DWR transmitted the full recommendations package of 21 reports including technical appendices for urban water use efficiency to the State Water Resources Control Board (State Water Board) pursuant to California Water Code Section 10609. These reports follow DWR's Summary Recommendations previously submitted to the State Water Board on September 29, 2022.

Required by legislation enacted in 2018 (Senate Bill 606 [Hertzberg] and Assembly Bill 1668 [Friedman]), the recommendations full reports can be found on DWR's Urban Water Use Efficiency Standards, Variances and Performance Measures webpage. The reports and technical appendices provide details on DWR's process including conducting the necessary studies and investigations, data analyses, development of the recommendations and guidelines and methodologies for urban water suppliers for calculating the annual water use objective. The documents also include information about the public engagement processes and public comments DWR received during the development of the recommendations.

Next month I will provide the recommendations to the Boar.

Limits Ability of Voters and State and Local Governments to Raise Revenues for Government Services. Initiative Constitutional Amendment.

Ballot Initiative 21-0042A1 would result in the loss of billions of dollars annually in critical state and local funding, restricting the ability of local agencies and the State of California to fund services and infrastructure by:

Adopting new and stricter rules for raising taxes, fees, assessments, and property-related fees.

Amending the State Constitution, including portions of Propositions 13, 218, and 26 among other provisions, to the advantage of the initiative's proponents and plaintiffs; creating new grounds to challenge these funding sources and disrupting fiscal certainty.

Restricting the ability of local governments to issue fines and penalties to corporations and property owners that violate local environmental, water quality, public health, public safety, fair housing, nuisance and other laws and ordinances.

The initiative includes provisions that would retroactively void all state and local taxes or fees adopted after January 1, 2022 if they did not align with the provisions of this initiative. This may also affect indexed fees that adjust over time for inflation or other factors.

The Ballot Proposition is currently undergoing signature verification. The new deadline for counties to complete the initiative signature verification process is February 1, 2023. The verification process currently has a 78% verify rate and is expected to reach the qualifying signatures.

This law goes into effect in January 2023. The Political Reform Act of 1974 prohibits an officer of an agency from accepting, soliciting, or directing a contribution of more than \$250 from any party, participant, or a party or participant's agent, while a proceeding involving a license, permit, or other entitlement for use is pending before the agency and for 3 months following the date a final decision is rendered in the proceeding, if the officer knows or has reasons to know that the participant has a financial interest, as defined. The act also prohibits a party, participant, or participant's agent from making a contribution of more than \$250 to an officer of the agency during the proceeding and 3 months following the date a final decision is rendered. The act defines "agency" for these purposes to mean any state or local government agency, except certain entities, including local government agencies whose members are directly elected by the voters.

The amendments include a change from 3 months to 12 months and defines officers as - Officer" means any elected or appointed officer of an agency, any alternate to an elected or appointed officer of an agency, and any candidate for elective office in an agency.

For example, a contribution over \$250 received after Jan 2023 for a GDPUD race would not only affect a permit or contract that may come before GDPUD, but if that elected has a contributor come before them for a contract or permit at EDWA or LAFCO etc...



- Met with Jeff Meyer from Western Hydrologic to discuss what he is working on. Also, learned of new issues that can help to expand our water supply and began discussing VA's (what are VA's) and transfers.
- Attended the Mosquito Fire FMAG meeting to determine if there are any costs that can be reimbursed based on the work that was done during the fire.

Week of October 16-22

- Met with Dane Wadle from CSDA to provide an introduction to the role CSDA plays and how the District can utilize its services.
- Attended the State Water Resource Control Board Meeting
- Met with Pioneer Energy to discuss the possibility of lowering our energy billing costs.
- Attending the CFCC funding fair to learn about any new grant funding opportunities that could be available in California and at the Federal level.
- Attended the California Drought Planning Workshop to discuss the potential response actions and plans for the state if it continues to be dry.
- Met with Director MacDonald.

Week of October 2-8

- Met with Director Thornbrough
- Met with Director Seaman
- Met with Ronald Slaven from Local 1 to discuss the Executive Assistant job description and also to go over the overall purpose of the union.
- Met with and toured the up-country canals and flume with the USDA-NRCS Assessment team. This was an opportunity to see if we could in any way utilize their Emergency Watershed Protection (EWP) funding program.
- Attended the Water Quality Coordinating Committee meeting.
- Met with Andy Fecko of PCWA to introduce myself and become acquainted with how they operate and how we work with them.
 - Discussed transfers, hydropower, and the VAs.

- Reviewed the grant writer RFP submittals with staff members to choose the best candidate for the position.
- Reviewed the salary survey RFP submittals with staff members to determine if the lone submission was a good option for the District.
- Attended the State Water Resource Control Board meeting
 - At this meeting they discussed and approved the water loss control plan for the state. This affects us as we will now have to comply with the regulations



Treated water and raw water deliveries decreased between 2020/2021 and 2021/2022 water year while the percent of water delivered that was put to beneficial use, treated and irrigation delivery, increased. The District saw an approximate 723 acre foot increase in water available for future use.



A water budget was prepared for water year 2022/2023 and is included below. Utilizing current supply, projected demand, available climate forecast and the District's forecast tool, expected inflow into Stumpy Meadows is estimated to range between 7,799 and 116,028 acre feet (ac-ft). Results indicate there is an 80 percent chance 2022/2023 Stumpy Meadows inflow will meet District demands and therefore it is anticipated no water delivery restrictions for the 2023 water season. Forecast output charts are included below.

Total Inflow to Stumpy Meadows Reservoir, Remainder of Water Year




Stumpy Meadows Reservoir Storage




CDS – Wastewater Discharge







Mosquito Fire Funding Possibilities

- 2. NRCS Emergency Watershed Protection (EWP) funding available for flume cover. 75% funding: \$42,000
- 3. CalOES/FEMA Fire Management Assistance Grants (FMAG) upcountry work on roads, erosion control Reimbursement funding up to 75%
- 4. CalOES/FEMA Hazard Mitigation Assistance Grants (HMAG) preventative measures (i.e. piping upper canal) Awaiting State Declaration of Disaster

Drought Grant Possibilities

Looked at the various Capital Improvement Projects which can be sought after for the Drought Resiliency Grant. Aim to get up to \$4 million in projects to qualify.

- 1. Automated Metering Infrastructure (\$150,000)
- 2. Building new water tanks (\$2,000,000) [2 million gal and (2) 500k tanks]
- 3. Convert up-country canals to pipe (\$1,500,000)
- 4. Lining low-country canals (\$500,000)
