

BACKGROUND

The Georgetown Divide Fire Safe Council (Council) has requested a letter of support for the Marshall Road/Georgetown Fuels Reduction Project. The Council is submitting a grant application to the California Department of Forestry and Fire Protection for approximately \$275,000 for this project.

DISCUSSION

The Marshall Road/Georgetown Fuels Reduction Project will provide safe evacuation routes in the event of a wildfire for the residents of Georgetown, Garden Valley, and surrounding areas, as well as create strategic anchor points for firefighting resources to slow or stop the spread of wildfire that originates to the southwest and downslope of Georgetown.

The project includes roadside fuel reduction work on 3.5 miles of Marshall Road, between Lower Main Street in Georgetown and Black Oak Mine Road in Garden Valley. Fuel reduction work (shaded fuel break) will be conducted within the county right-of-way on private parcels: 10-40 feet on either side of the road. On Bureau of Land Management (BLM) parcels, work will extend to up to 200 feet on either side of the road.

Roadside fuel reduction work on Marshall Road, between Lower Main Street in Georgetown and Black Oak Mine Road in Garden Valley is included in the project. Fuels work will be conducted within the county right-of-way on private parcels: 10 to 40 feet of the road for the 3.5 mile length of Marshall Road on BLM parcels.

FISCAL IMPACT

None.

CEQA ASSESSMENT

This is a project of the Georgetown Divide Fire Safe Council and does not involve a CEQA Assessment by GDPUD.

RECOMMENDED ACTION

Staff recommends that the Board of Directors of the Georgetown Divide Public Utility District authorize the General Manager to send a letter of support of this project.



BACKGROUND

In the past, Directors have participated in conferences offered by the Association of California Water Agencies (ACWA) to connect and stay current with the water industry. Program offerings include Statewide Issue Forums, Town Hall discussions, Region Programs, and sessions covering a wide range of topics including groundwater management, water rates issues, crisis communications, affordable drinking water issues, municipal finance, and more.

DISCUSSION

The 2021 ACWA Spring Virtual Conference is scheduled for May 12-13, 2021. The conference brochure is included as Attachment 1.

In accordance with Board adopted District policy, conference attendance and travel by Directors is paid on a reimbursement basis. Developments in Proposition 218 and the Law of Water Rates

Water rates are under continuing legal attack throughout the state. Retail water suppliers must collect and fairly allocate the costs of service among their ratepayers, and even well-designed plans may come under attack from disgruntled users and their often entrepreneurial attorneys – who take the cases on contingency and bet on being able to collect their fees from the retailer. A class action case filed against 81 water retailers last year brought the threat of these suits and their financial impact into sharp focus. And recent case law proves to be a mixed bag for water agencies. This program will examine the impact of recent legal decisions, the threats posed by certain current cases, recent and proposed legislation affecting rate setting and collections, and propose some practical steps retailers might consider to reduce the risks of Prop. 218 challenges.







BACKGROUND

The Georgetown Divide Public Utility (District) has prepared this report in compliance with the Urban Water Management Planning Act (Act), as amended (California Water Code, Division 6, Part 2.6; §10610, et. seq. established by Assembly Bill 797, 1983). All urban water suppliers defined in Section 10617; either publicly or privately owned, providing water for municipal purposes either directly or indirectly to more than 3,000 customers, or supplying more than 3,000 acre feet (ac-ft) annually are required to prepare an UWMP. Urban water suppliers are required to prepare and/or update their Urban Water Management Plan (UWMP) and submit a complete plan to the DWR every five years.

DISCUSSION

The District has prepared this 2020 UWMP to be utilized as a resource/planning document for the District and to meet State of California Department of Water Resources (DWR) requirements. The District is classified as an urban water supplier that provides treated water to approximately 3,800 customers and seasonal irrigation water to approximately 400 customers from a single surface water supply, the Stumpy Meadows Reservoir.

Stumpy Meadows Reservoir is located along the Pilot Creek channel which is a tributary to Rubicon River and part of the larger American River Watershed. Mark Edson Dam, completed in 1962, impounds Stumpy Meadows Reservoir at a total capacity of 20,000 ac-ft. Supply is conveyed to the customers in the form of treated water and raw irrigation water by a canal/conduit system and a distribution piping network. In 2020, the District supplied approximately 1,400 ac-ft of treated drinking water and 4,000 ac-ft of raw irrigation water. Projected 2040 approximate water use is calculated at 1,800 ac-ft for treated water and 5,000 ac-ft for raw irrigation water. Without accounting for improvements, total projected water uses in 2040, including treated and raw water losses, is estimated at approximately 9,500 ac-ft annually.

Based on historical dry year data, we have determined that the District has adequate source of supply to meet 20-year demand projections, including for a single dry year and multiple dry year scenarios. Water conservation thresholds have been established to ensure these demands are met during multiple drought scenarios. The heart of water conservation methods is best management practices of annual raw irrigation water deliveries. Approximately 70 percent of District water deliveries include raw irrigation water. District policies call for an annual evaluation of the District's water supply so the District's Board of Directors can modify irrigation deliveries accordingly to ensure State of California and the District health and safety priorities are met to provide a reliable and consistent supply of safe drinking water to District treated water customers. In addition, with the projected increase in demand the District actively evaluates demand measurement methods in order to ensure adequate and reliable water supply.

FISCAL IMPACT

If the District did not meet State requirements, a fine could be levied against the District.

CEQA ASSESSMENT

This is not a CEQA project.

RECOMMENDED ACTION

Staff recommends that the Georgetown Divide Public Utility District Board of Directors provide any comments for inclusion into the UWMP. The final draft of the UWMP will be presented during the June Board meeting for adoption by the Board, as the State requires adoption of the plan by June 30th, 2021.
