

per your request I am forwarding a formal letter of resignation per the Finance Committee policy written by Board President Saunders and forwarded to the Finance Committee on April 7, 2022. At the same time he wrote "Welcome to the Finance comm" which after 3 pages of Instructions to the Chairman ended on pp 3 and 4 with Background Security summary. Stating cyber terrorism and domestic terrorism still are rampant in the Divide. (My FBI friend isn't aware that those types of terrorism exist on the Divide.)

Also he stated that any retrofitting of the District Office building (bullet proof glass, etc.,) be listed under Covid expenses. I found that unfair to the water customers
