WHEREAS, since April 11, 2017, the District has been receiving CPA services from Vavrinek, Trine, Day, & Co., LLP (VTD) when their services were retained to review the District's finance and accounting operations in an amount not to exceed \$9,500; and

WHEREAS, when that initial scope of work was completed with satisfactory performance, the District requested a proposal from VTD to provide finance manager services; and

WHEREAS, the Board of Directors approved a Professional Services Agreement with VTD on August 8, 2017, for an amount not to exceed \$89,100 and approved amendments to that original agreement for subsequent fiscal years, with the current Agreement providing for a total Agreement amount not to exceed \$231,960; and

WHEREAS, the General Manager plans to conduct a review of all current Professional Services Agreements in the near future. Due to the current financial situation, Staff would like to issue an RFP for CPA services.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE GEORGETOWN DIVIDE PUBLIC UTILITY DISTRICT THAT the General Manager is directed to prepare a Request for Proposals for Certified Public Accounting services for review by the Board of Directors for issuance.
